**IT IS HEREBY AGREED by the parties hereto as follows:** Any person(s) using this facility must be aware that there is great risk involved in any equine activity for handlers, riders, and spectators. The use of livestock, horses, mules, cattle, etc. can result in injury or death to anyone in the vicinity. The mentioned livestock may bite, kick, buck or run away at any time and can cause personal injury. All reasonable care has been taken in the construction, planning and use of this facility. The Richland Riders Club (RRC), or its individual members, will not be held liable for any injury or accident. Any person bringing legal action or suit agrees to pay any legal fees incurred by the Richland Riders Club, or its individual members.

If a horse is destructive of any property located in this facility, the Participant is personally responsible for all damages to said property. If a horse is unmanageable or dangerous to other persons, the Participant will be asked to vacate said premises immediately.

**I have read and will abide by the following Richland Rider Club facility rules:**

- A) While mounted, minors (under 18 years of age) must wear ASTM (American Society of Testing Materials) or equivalent approved helmets. The harness must be secured. This rule is to be enforced by parents or the RRC member who invited the minor.
- B) While jumping, any rider must wear an ASTM or equivalent helmet with harness fastened.
- C) Boots or shoes with at least a one-half (1/2) inch heel must be worn by all riders using stirrups.
- D) Do not leave your horse unsupervised or tied inadequately.
- E) Do not handle a horse that belongs to another person without their permission.
- F) Always keep your horse under control for the safety of other riders and participants.
- G) Close entry gate to the RRC behind you after entry and exit of facility.
- H) Children must be supervised by an adult (16+ years old) at all times.
- I) Dogs must be leashed and attached to a human, and dogs are not allowed on or inside the track area. No exceptions.
- J) Smoking is ONLY allowed in the track area.
- K) Dispose of all trash in appropriate containers.
- L) Water at the RRC facility is safe for horses and animals but not safe for human consumption.
- M) Day pens that are used shall be cleaned of all manure and old hay after use. Day pens will not be moved unless approved by an RRC board member. If day pens are not cleaned after use, a \$15.00 additional fee will be charged for the RRC to clean the day pens.
- N) All non-members must sign a waiver prior to the event starting. RRC waivers will be provided on the day of the event.
